Treasurer's report

Pledges are a little under budget. Now that things are opening up a little, loose offering and facility use donations are increasing, although still lower than budget.

Expenses are about at or under budget, depending on the category.

Monthly income is about \$5700 less than monthly expenses. Year-to-date income is about \$5100 more than year-to-date expenses.

I am requesting the annual Osgood and Parker Cook contributions this month.

Prospect Church policy for dealing with people sleeping on our porch :

Meighan shared a document from Plymouth UCC. Cora re-worded it to fit Prospect and came up with the following draft:

PROSPECT CONGREGATIONAL UNITED CHURCH OF CHRIST

RULES OF CONDUCT

Welcome to Prospect and we ask that you honor these rules to preserve the health, safety and well-being of all.

While on the property or in the building of Prospect UCC, the following are prohibited:

- Smoking in the building or within 25' of an entrance*
- Weapon possession, except by law enforcement*
- Illegal substance possession*
- Threatening, disruptive, obscene or discriminatory behavior or language*
- Distribution of materials (unless approved by church staff)*
- Any activity that damages the church building or its contents*
- Indecent exposure, offensive touching or sexual harassment*
- Conduct that interferes with others' use of the church*
- All forms of violence*

We make every effort to apply these rules in a fair, humane and positive manner for the benefit of all. Individuals whose actions violate these rules will be asked to stop such actions and we reserve the right to require anyone violating these rules of conduct to leave the premises. 911 may be called if there is immediate danger. We may withdraw permission for a person to return to the property if that person continues to violate these rules.
